#### **European Society of Veterinary Clinical Ethology**

Through this grant, ESVCE aims to encourage the development of interest in clinical ethology and to provide an opportunity to conduct relevant research or other projects related to the field (e.g. educational). We welcome applications from clinicians and researchers of all levels of experience; this includes students (who are studying veterinary medicine or another animal behaviour related degree) and veterinarians and other professionals working in the field of clinical ethology. N.B. All applicants must be current members of the ESVCE in good standing.

ESVCE wishes to promote high quality research that is likely to lead to substantial improvements in clinical ethology through providing new insights and/or promoting applied research aimed at developing practical solutions for dealing with behavioural problems. In parallel ESVCE is concerned with the welfare of companion animals and is an advocate of welfare-focussed handling and training.

For successful applicants, it is mandatory that they keep in touch regularly with the ESVCE Board every 6 months following provision of funding, and that on completion of the funded work, a report is sent to the committee to be included in the next ESVCE Annual General Meeting. In addition, it is strongly encouraged that successful applicants submit their work for consideration to be included in annual European Veterinary Congress of Behavioural Medicine and Animal Welfare (<a href="https://www.evcbmaw.org/">https://www.evcbmaw.org/</a>), a congress jointly organised by ESVCE, ECAWBM, AWSELVA and a different national group representing members interested in behavioural medicine and welfare.

#### **Applications**

Applications must be made on the attached form. One copy of the of the application form with an electronic signature, together with a copy of the student's CV (no more than 2 sides of A4) should be sent electronically to <a href="mailto:board@esvce.org">board@esvce.org</a>

The grant consists of EUR 2000. Payments are made after acceptance of application to the bank account stated in the application

In addition, in the event of a grant recipient submitting and successfully being accepted to present findings from their work at the annual European Veterinary Congress of Behavioural Medicine and Animal Welfare (<a href="https://www.evcbmaw.org/">https://www.evcbmaw.org/</a>). The fee for attending congress, travel costs and up to 2 nights accommodation to allow presentation at the conference (to a maximum total value of EUR 1000) will be reimbursed on submission of receipts to the ESVCE Board.

Each grant application will be reviewed anonymously by two or more reviewers selected by the ESVCE board.

#### **Notes and Conditions**

#### Use of funds

- 1. Projects and procedures funded by ESVCE grants may not be altered from those specified on the application form and in the grant authorisation from ESVCE without prior written permission of ESVCE.
- Where funds are granted to an institution for the employment of staff at that institution or for work to be carried out by a private individual, ESVCE is not the employer. It is the responsibility of the host institution to issue a contract of employment in accordance with the respective legislation in the country and with any other employment legislation. Full details of all employment costs should be provided in the application, when necessary.
- 3. The period of the grant is strictly limited and the tenure of appointment of any persons employed by the host institution for the work must be confined strictly to the period of the grant. If staff are retained beyond this it is for the host institution's own purposes and at their own expense.
- 4. All grants are made on the condition that ESVCE is in no way responsible for claims under any statute or at common law and it does not indemnify the host institution against any claim for compensation or against any other claims for which the host institution may be liable as an employer, owner-occupier or user of premises or as the provider of services or facilities or in relation to the work carried out under the grant.
- 5. Any equipment purchased from an ESVCE grant will become the property of ESVCE and should be used only for the activities approved. At the end of the project the ownership and future use of the equipment will be reviewed by ESVCE.

#### Legal and ethical

6. It is the responsibility of the applicant to be aware of all laws and codes under which the work is to be carried out and to abide by these and to obtain all necessary permissions and licences.

#### Use of animals

- 7. If the proposed work involves the use of animals, it is the responsibility of the principal applicant to check with the appropriate national or regional authority regarding the need for licences or other specific authorisation required in the country concerned and to obtain these where necessary. It is also the responsibility of the principal applicant to obtain the necessary approvals from the institution's ethics committee where there is one.
- 8. ESVCE requires rigorous implementation of the 3Rs. Where animals are used in research they must be afforded high standards of welfare compatible with the aims of the research. At all times conditions for husbandry and experimentation should be of high standard conducive to good welfare and to minimising stress. Enclosures should meet the physiological and behavioural needs of the animals and appropriate enrichment should be provided. The health of the animals should be maintained and monitored, and any deterioration attended to immediately. All staff involved in animal research, both at a scientific and research support level, and those involved in the breeding, handling and care of animals, must be appropriately trained and possess relevant qualifications.
- 9. In order that ESVCE can be satisfied fully that projects involving the use of animals take the fullest possible account of their welfare, applications should include details of the following (as appropriate) in the description of the methods:

animals - species, strain, weight, sex, age, source, transport, health status, conservation status, fate at end of project;

housing/feeding/measures to improve welfare - cage/enclosure type, size, floor, furnishings, bedding, cleaning, thermal environment, number of animals per cage, diet, feeding regime;

experimental design - experimental design, details of how numbers in test and control groups have been determined (e.g. by power analysis prior to the experiment), statistical methods to be used in analysis of the results;

experimental procedures - experimental procedures, any risks to animal welfare (nature and duration), measures to improve the animals' welfare, analgesia, methods of euthanasia.

Applicants may find useful, and are recommended to familiarise themselves with, the Association for the Study of Animal Behaviour's Guidelines for the treatment of animals in behavioural research and teaching: <a href="https://www.asab.org/ethics">https://www.asab.org/ethics</a>

#### Limitation of liability

10. ESVCE is in no way responsible, financially or otherwise, for the expenditure or liabilities arising out of the work other than those specifically listed and defined in the project proposal or approved in further correspondence.

#### Publication of reports and copyright

11. In the first instance, reports should be considered confidential to ESVCE. Subsequently, by prior mutual agreement, the authors or ESVCE may publish the report or offer it in part or entirety for publication. However, ESVCE reserves the right to publish the brief account of the project and any accompanying illustrations in its publications, either as submitted or after editing at ESVCE's discretion, and without prior discussion with the Scholar or his/her supervisor.

Where the Scholar or his/her supervisor, having obtained ESVCE's permission to do so, publish the work or aspects of it, ESVCE's support should (unless otherwise specified by ESVCE) be duly acknowledged. A draft copy of any proposed article should be submitted to ESVCE for permission prior to submission for publication. Reprints of articles arising from work supported or partially supported by ESVCE should be sent to ESVCE in due course.

#### **Termination of grants**

12. ESVCE has the right to revoke or suspend any grant upon failure to observe any of the conditions listed above or specified by ESVCE in the offer of a grant or on consideration of the progress of the work. In such a case, ESVCE may require repayment or, depending on the circumstances, may reimburse the host institution for expenses incurred to the date of termination but will not be responsible for, nor will indemnify the host institution against, any claims (relating to employment or anything else - see conditions above) arising as a result of the termination.

#### Reports

13. Applicants are required to submit a written report of their projects. These should be presented in the following format:

an abstract of 100 – 200 words the aim full details of the background including a critical review of related literature a clear explanation of the method results with appropriate tables, diagrams, figures and statistical analyses discussion including subsection on animal welfare implications



summary of conclusions and recommendations references (quoted in full)

Reports should, as far as possible, be prepared in the format of papers published in the Journal of Veterinary Behavior (and applicants are encouraged to consult the instructions for authors for this journal). Reports need be no longer than necessary to clearly and concisely describe the project. There is no merit in producing unnecessarily lengthy reports. Please submit your final report to ESVCE's secretary. Applicants are also required to provide photographs or videos illustrating their project or the animals involved in it for inclusion in ESVCE publications.

#### Brief account of project

14. In addition to the main report, each applicant is required to submit a brief (200-300 word) account of their project which is written in an easily accessible style suitable for inclusion in the ESVCE report for the AGM. This should explain the background of the project and its benefits.

#### Supervisor's assessment

15. Project supervisors are asked to submit a brief assessment of the success or otherwise of the project when submitting the applicant's report to ESVCE.

#### **Deadline**

16. The project report and the brief account of the project (see above) must be submitted, to ESVCE by 1st November in the year the project is undertaken.

Please note that failure to comply with these conditions and to submit reports on schedule may result in the disqualification of the applicant or of his/her organisation from obtaining grants from ESVCE in future.

#### **Oral Presentations**

17. ESVCE regularly holds meetings at which applicants are expected to present their work, once finished, to an audience.
